COMMITMENT TO THE ERASMUS CHARTER PRINCIPLES

Declaration

I, undersigned, declare that if my institution is awarded with an Erasmus Charter for Higher Education, my institution will undertake to:

- Respect in full the principles of non-discrimination, transparency and inclusion set out in the Programme.
- Ensure equal and equitable access and opportunities to current and prospective participants from all backgrounds, paying particular attention to the inclusion of those with fewer opportunities.

ESPAÑOL: La Escuela de Arte y Superior de Diseño Gran Canaria tiene implementado el programa Erasmus con muchísimo éxito y deseamos renovar nuestro compromiso con el Programa a través de la obtención de la nueva Carta ECHE 2020. El Programa Erasmus nos ha dado la posibilidad, en primer lugar, de visibilizar la Educación Arte y la Educación Superior de Diseño que se desarrolla en la Isla de Gran Canaria. Nuestra situación geográfica de ultraperiférica marca una diferencia con el resto de centros de enseñanza de este tipo a lo largo de la península ibérica haciendo más complicada la interacción directa y el intercambio tanto de experiencia educativas como de naturaleza profesional. Ni que decir tiene que con respecto al resto del continente, las opciones de intercambio son muchísimo mas improbables sin un programa como el Erasmus que nos acerca a Europa gracias a las ayudas económicas que posibilitan que tanto nuestro alumnado como nuestro profesorado pueda viajar a otros países y experimentar otras realidades educativas y profesionales. Esa ultraperiferia antes comentada y nuestro contexto sociocultural hace que el programa Erasmus sea fundamental para que muchos jóvenes puedan tener una experiencia “europea” que de otro modo no podrían plantearse.

Con las movilidades KA103 para Estudios, todos los años, una media de 10 alumnos, cursan el segundo semestre de su tercer curso de Enseñanzas Artísticas Superiores de Diseño en alguna Universidad Europea. Estas movilidades añaden una motivación extra para todo aquel alumnado que disfruta de las ayudas económicas, completa y/o complementa la formación enriqueciendo su título académico gracias de los contenidos y las metodologías adquiridas en los países de destino. Las memorias realizadas por los alumnos después de sus movilidades nos ayudan, como institución, a tener una visión de la práctica educativa en otras instituciones así como a crear lazos de colaboración mas allá de las movilidades de estudios. Estas se concretan en muchos casos en movilidades de profesorado tanto salientes como entrantes, para formación de los propios docentes o para la impartición de talleres, master-class o clases magistrales al alumnado. Estas interacciones hacen que nuestra Escuela de Arte pueda acercarse a la vanguardia del resto de instituciones europeas.

Nuestro objetivo para esta etapa con la nueva Carta ECHE son los siguientes:

- Continuar promoviendo entre el alumnado de los Ciclos Formativos de Grado Superior realizar sus prácticas profesionales, certificadas, a través del programa Erasmus. De este modo los alumnos completan sus formación académica cumpliendo sus horas de formación en centro de trabajo en empresas Europeas fuera de España.
- Continuar promoviendo entre el alumnado de Enseñanzas Artísticas Superiores de Diseño la realización de el segundo semestre de su tercer curso en una institución Europea fuera de España, completando y complementando su formación académica y reconociendo los créditos ECTS cursados.
- Continuar promoviendo entre el profesorado las movilidades de docencia en centros educativos europeos fuera de España, fomentando el intercambio educativo.
- Continuar promoviendo entre el profesorado las movilidades de aprendizaje en centros educativos europeos fuera de España. fomentando la formación continua, la modernización de nuestro centro educativo y la diversidad cultural.
- Seguir apostando por conseguir un proyecto KA107 que nos de la posibilidad de recibir alumnado de países que no pertenecen a la unión europea y de poder desarrollar proyectos educativos y artísticos conjuntos.
- Mejorar nuestros canales de difusión del programa Erasmus a través de la modernización de la página web, además de la creación de publicaciones online e impresas (siempre y cuando se crean necesarias).

ENGLISH: The Gran Canaria School of Art and Design has successfully implemented the Erasmus program and we wish to renew our commitment to the Program by obtaining the new ECHE 2020 Charter. The Erasmus Program has given us the possibility, first of all , of making Art Education and Design Higher Education

visible on the island of Gran Canaria. Our outermost geographical location makes a difference with the rest of educational centers of this type throughout the Iberian Peninsula, making direct interaction and the exchange of both educational and professional experiences more complicated. The Erasmus programme brings us closer to Europe thanks to the financial aid that enables both our students and our teachers to travel to other countries. and experience other educational and professional realities. This aforementioned outermost region and our socio-cultural context make the Erasmus program essential so that many young people can have a "European" experience that they could not otherwise consider.

With the KA103 Mobilities for Studies, every year, an average of 10 students take the second semester of their third year of Higher Artistic Design Education at a European University. These mobilities add extra motivation for all those students who enjoy financial aid, complete and / or complement the training, enriching their academic title thanks to the content and methodologies acquired in the destination countries. The memories made by the students after their mobility help us, as an institution, to have a vision of educational practices in other institutions as well as to create bonds of collaboration beyond study mobility. In many cases, these take the form of both outgoing and incoming teacher mobility, for the training of the teachers themselves or for the delivery of workshops, masterclasses or master classes to students. These interactions allow our Art School to approach the vanguard of the rest of European institutions.

Our objective for this stage with the new ECHE Charter are the following:

- Continue promoting among the students of the Higher Level Training Cycles to carry out their certified professional practices through the Erasmus program. In this way, students complete their academic training by completing their training hours at the workplace in European companies outside of Spain.
- Continue promoting among the students of Higher Artistic Teaching in Design the completion of the second semester of their third year in a European institution outside of Spain, completing and complementing their academic training and recognizing the ECTS credits taken.
- Continue promoting teaching mobility in European educational centers outside Spain among teachers, promoting educational exchange.
- Continue to promote learning mobility in European educational centers outside of Spain among teachers. promoting continuous training, modernization of our educational center and cultural diversity.
- Continue betting on getting a KA107 project that gives us the possibility of receiving students from countries that do not belong to the European Union and to be able to develop joint educational and artistic projects.
- Improve our channels for disseminating the Erasmus program through the modernization of the website, as well as the creation of online and printed publications.

- ESPAÑOL:** Del mismo modo que hemos venido trabajando en los últimos años esperamos continuar con las movilidades KA103 y mejorar la asignación de movilidades para el Programa KA107.
- El programa Erasmus está ya consolidado en nuestra Institución y forma parte de la realidad de nuestro centro y de las expectativas de nuestro alumnado y profesorado. Continuar ofreciendo movilidades Erasmus y seguir formando parte de las instituciones europeas que apuestan por la modernización de su oferta educativa es una prioridad.
- ENGLISH:** In the same way that we have been working in recent years, we hope to continue with the KA103 mobilities and improve the allocation of mobilities for the KA107 Program.
- The Erasmus program is already consolidated in our Institution and forms part of the reality of our center and the expectations of our students and teachers. Continue to offering Erasmus mobility and remaining part of the European institutions that are committed to modernizing their educational offer is a priority.

- Esperamos seguir creciendo como centro de referencia para la Educación Artística en Las Islas Canarias, siendo nuestro centro el más demandado de las cuatro Islas que cuentan con Escuela de Arte para la realización de movilidades entrantes desde países como Portugal, Italia y Alemania, sobre todo.
- Recibir a este alumnado ha propiciado en primer lugar, sinergias dentro del aula, que de otro modo serían impensables. Para empezar, el bilingüismo, ya que la mayoría de los alumnos que vienen a estudiar a nuestro centro no hablan Español, por tanto, tanto profesorado como alumnado se relacionan con este alumnado en Inglés, en un principio. Además, el profesorado adapta los contenidos y las entregas y exámenes a esta lengua. Esto es muy positivo para la comunidad en su conjunto.
- Del mismo modo, este alumnado viene con una experiencia educativa que en algunos casos muestra similitudes con nuestras dinámicas diarias, pero que en otros casos, trae metodologías y formas de trabajo diferentes, que comparte con el grupo clase, enriqueciendo la relación en ambas direcciones.
- La movilidad de estudiantes salientes a países de la Unión Europea seguirá siendo preferente.
- Seguiremos trabajando en conseguir nuevos acuerdos interinstitucionales para ampliar la oferta de centros donde puedan realizar movilidades de estudios nuestros estudiantes. Esto se lleva a cabo a través de visitas a distintos centros que previamente se ha comprobado que cumplen con las necesidades educativas de nuestras enseñanzas. Algunos de nuestro profesores con dominio de idiomas visitan los centros y por supuesto, se invita a realizar una visita de vuelta a nuestro centro para ambas

instituciones podamos conocernos y encontrar los puntos de interés para nuestro alumnado.

- Seguiremos trabajando en aumentar la oferta de empresas y autónomos en la Unión Europea para que nuestro alumnado pueda realizar prácticas de empresa certificadas. Desde la oficina Erasmus se ayuda de forma individual a cada alumno en la búsqueda de empresas, a través de vías telemáticas.
- Pretendemos continuar con el mismo número de movilidades ya que la experiencia de estos últimos años nos dice que, de momento, hemos llegado a la cima respecto la oferta y la demanda. Estos es: 10 movilidades de estudios aproximadamente, 30 movilidades de prácticas aproximadamente y 6 movilidades de profesor aproximadamente.
- ENGLISH: We hope to continue growing as a reference center for Artistic Education in the Canary Islands, being our center the most demanded of the four Islands that have an Art School to carry out incoming mobility from countries such as Portugal, Italy and Germany, especially.
- Receiving these students has, in the first place, fostered synergies within the classroom, which would otherwise be unthinkable. To begin with, bilingualism, since most of the students who come to study at our center do not speak Spanish, therefore, both teachers and students relate to this student in English, initially. Furthermore, Teachers adapt the content and the deliveries and exams to this language. This is very positive for the community as a whole.
- In the same way, these students come with an educational experience that in some cases shows similarities with our daily dynamics, but that in other cases, brings different methodologies and ways of working, which are shared with the class group, enriching the relationship in both directions.
- The mobility of outgoing students to countries of the European Union will continue to be preferred. We will continue working to achieve new inter-institutional agreements to expand the offer of centers where our students can carry out study mobility. This is carried out through visits to different centers that have previously been proven to meet the educational needs of our teachings. Some of our language proficient teachers visit the centers and of course, we invite them to make a return visit to our center so that both institutions can meet and find points of interest for our students.
- We will continue working to increase the offer of companies and self-employed in the European Union so that our students can carry out certified business practices. The Erasmus office helps each student individually in the search for companies, through electronic channels.
- We intend to continue with the same number of mobilities as the experience of recent years tells us that, for the moment, we have reached the top regarding supply and demand. These are: approximately 10 study mobilities, approximately 30 practice mobilities and approximately 6 teacher mobilities.

- La Escuela de Arte y Superior de Diseño Gran Canaria se caracteriza por ser un centro inclusivo y no discriminatorio. Contamos con una Comisión de Igualdad que funciona desde hace mas de tres años y uno de los valores que nos abandera es la diversidad. Respetamos desde todo el claustro de profesores la ley de identidad de género, así como atendemos a la diversidad y presentamos tolerancia cero antes la discriminación de cualquier tipo.
- Los protocolos de selección del alumnado son transparentes y públicos. Cada año, en el mes de Octubre se hace una primera reunión con el alumnado de segundo curso de Ciclos Formativos para informarles de los trámites que deben realizar para solicitar una movilidad Erasmus de prácticas. A finales de ese mismo mes se convocan las pruebas de nivel de Idioma que, junto a la expediente académico del alumnado, servirán para realizar la selección. Esta información se publica en la Plataforma EVAGD y además está disponible en el tablón de anuncios de la Oficina Erasmus. El listado de alumnado seleccionado se publica igualmente en ambos medios.
- En el mes de Abril se realiza una segunda reunión con alumnado de segundo de Enseñanzas Artísticas Superiores para explicarles cuales son los trámites para solicitar la movilidad de Estudios para el primer semestre de sus tercer curso. A finales de ese mismo mes se convocan las pruebas de nivel de Idioma que, junto a la expediente académico del alumnado, servirán para realizar la selección. Esta información se publica en la Plataforma EVAGD y además está disponible en el tablón de anuncios de la Oficina Erasmus. El listado de alumnado seleccionado se publica igualmente en ambos medios.
- En el mes de Noviembre se convoca al profesorado a través del Tablón de Anuncios de las sala de profesores y a través de los jefes de departamento. La selección se realiza en base la evaluación del proyecto presentado y baremo de méritos. La selección se publica en el tablón de anuncios de la oficina Erasmus y en la Plataforma EVAGD.

- Se realizan y se seguirán realizando jornadas de difusión Erasmus donde alumnos y profesores que ya han realizado movilidades exponen sus experiencias en los países de destino. En estas jornadas también participan alumnos incoming que relatan su periodo en la escuela. Se discute sobre las diferencias y similitudes en la vida diaria, sobre la adaptación las primeras semanas y sobre los métodos de trabajo y estudio.
- A partir del curso 2020-2021 se comenzará a trabajar con un programa que hemos denominado "Erasmus wellcome". Este programa, estará formado por un comité de bienvenido compuesto por alumnos de la escuela que acompañarán los primeros días al alumnado incoming para ayudarles a realizar las gestiones necesarias para comenzar su vida en la Isla y por supuesto a mostrarles, las características y el ritmo de vida en la misma. Fomentamos el uso de los servicios públicos de transporte tanto guaguas como bicicleta "citycleta" además de contar con distintos proyectos a lo largo de los dos semestres que promueven a través de los contenidos transversales los valores de convivencia.
